President Barrett provided the following report:

 Northeast Community College marked its 48th annual commencement with six ceremonies May 21-22. Approximately 905 graduates, including those earning more than one degree, and

- 259 who completed their studies this past summer and fall, were listed in commencement programs.
- Thirty-six associate degree nursing and 41 practical nursing students were recognized during
 a special ceremony with the presentation of their nursing pins and their diplomas. In a normal
 year, the ceremonies are held separately, but in 2021 the tradition of nursing students receiving
 their pins from family members or a close friend who have helped them along their journey
 returned.
- Northeast Community College is offering free tuition to students who enroll in summer credit
 classes. Free tuition is designed to remove financial barriers for students who have been
 negatively affected by the pandemic. It is also an opportunity to help them stay on track or
 assist new students beginning their education. This includes high school students who want to
 get ahead, current students or students from other colleges who want to transfer credits.
- Northeast Community College is collaborating with Franciscan Healthcare to offer opportunities for students that will help address workforce demands at its facilities in West Point. The new Educational Assistance Program includes paying for students to complete their coursework through the College in Practical Nursing/Associate Degree in Nursing or the Health Information Management System (HIMS). As part of the program, qualified students who are selected will have their tuition paid in full and are guaranteed employment at Franciscan Healthcare after completion of their programs.
- Northeast Community College is one of 25 colleges that has been selected to participate in a
 program that is designed to better align student goals for career and continuing education
 opportunities. Following a competitive application and interview process, the Teacher's
 College at Columbia University selected teams representing 25 colleges in 19 states, including
 Northeast, to participate in its Summer 2021 Institute, Guided Pathways at Rural Colleges:
 Using Data to Launch Large-Scale Reform. The institute will be hosted by the Community
 College Research Center (CCRC).
- Present and past Northeast Community College employees came together for an end of year
 celebration and to mark the farewell of several members who have or are about to retire.
 Retirees were recognized and also presented "retirement good wishes boxes" containing cards
 and notes of congratulations from their co-workers. Their work equals a combined total of 624
 years of service to Northeast Community College.
- Two longtime employees who are retiring this summer have been conferred with emeritus status. Karen Severson, who currently serves as interim associate vice president of human resources, was conferred with the emeritus award as Vice President of Student Affairs, a position she held for most of her 28-years at the College. Debb Strate, Executive Assistant in the Ag, Math and Science Division, has also been awarded with emeritus status for her meritorious work at the College. Debb began her employment at Norfolk Junior College in 1968. Karen's and Debb's names will soon be included on the Emeriti Wall Plaque in the Maclay Building to recognize this honor.
- A representative on behalf of the Gene Hass Foundation presented a \$10,000 check to Northeast Community College recently to assist students in the College's Machining and Manufacturing Automation program. The funds will be used to provide scholarships to students enrolled in the program.
- Approximately 60 high school students from across the region had the opportunity to get exposure to various careers in the healthcare industry recently. Northeast held its annual Health and Wellness Summer Expos on the Norfolk and South Sioux City campuses.

- Northeast's main New Student Registration (NSR) days took place May 26 through June 9. It is during this time that the bulk of new students planning to start at Northeast during the Fall 2021 semester register for classes, meet with advisors, financial aid, and residence life, among others on campus. Over the nine days of NSR, 802 students register for fall classes, which set a new record for the event. There will be a New Student Registration event at the Extended Campus in South Sioux City on June 15, followed by some virtual and smaller-scale face-to-face New Student Registration events throughout the summer.
- Ashley Pena, Norfolk, was named the TRIO program's Student of the Month in April. Pena, who graduated with an Associate of Arts degree with a concentration in Elementary Education from Northeast in May, plans to transfer to the University of Nebraska at Kearney where she will pursue a Bachelor's degree in Elementary Education with an emphasis in English as a Second Language.
- Four special visitors to Northeast Community College recently allowed students to let their cares slip away for a short period of time. The golden retrievers are trained comfort dogs and exhibit a gift of love and gentleness with whomever they encounter. They spent time with the students in the College's Union 73 on the Norfolk campus.
- The Northeast women's soccer season officially ended this past weekend after finishing 1-1 at the National Junior College Athletic Association (NJCAA) Division National Tournament in Evans, Georgia. #9 Northeast fell to #4 Heartland Community College (Ill.), 2-0 and defeated #5 Howard Community College (Md.) 2-1. Heartland also defeated Howard to move on to advance out of pool play. The Hawks finish the season at 13-4-1 overall and 10-3-1 in the Iowa Community College Athletic Association's Division (ICCAC).
- Northeast's Ty Heimes finished in a tie for 37th place out of 123 golfers at the NJCAA Division 2 National Tournament at the Swan Lake Golf Resort in Plymouth, Ind. He shot a 2-under par 70 to sit in eighth place after Round One. He followed with an 83 on day two, while carding a 76 on the third day of the tourney. Heimes ended with a four-day total of 306 after carding a 77.
- Naomi Pedroza, Hastings, was named the ICCAC Division 2 Women's Soccer Player of the Year; Chad Miller was named the ICCAC DII Women's Soccer Coach of the Year; Ty Heimes, Battle Creek, was named to the ICCAC's All-Region Second Team; and Colin Lynam, Springfield, named to the NJCAA's All-American Third Team.
- Ninety-three Northeast student-athletes were named to the ICCAC's 2021 Spring Academic All-Region Teams. To be named to All-Region Academic First Team, the student-athlete must have earned a 3.5 and above grade point average (GPA). To be named to the All-Region Academic Second Team, the student-athlete must have earned a 3.0-3.49 GPA.

Steve Anderson, NCCA Board of Directors representative, reported that Greg Adams, NCCA Executive Director, will be retiring, effective December 31, 2021. NCCA hopes to conduct interviews in July, having the new person in place by November 1st to provide training with Mr. Adams through the end of the year.

The next quarterly Board of Directors meeting will be held in August at which time the NCCA budget will officially be approved. The NCCA Annual meeting will be held October 3-4, 2021 in Scottsbluff.

Steve Anderson will participate in the Association of Community College Trustees (ACCT) Board of Directors Retreat in July. At that time, four candidates will be interviewed to replace J. Noah Brown. Mr. Brown has represented ACCT for 20+ years. Plans are to bring the new person on board by October.

- 1. The Student Success Committee was convened at 10:08 a.m. by Donovan Ellis, Chairperson of the Student Success Committee, in Room 1108B in the College Welcome Center.
- 2. Recommended approval of the Minutes of the May 13, 2021 meeting as distributed.
- 3. The program review of the Agriculture programs at Northeast Community College was provide by Corinne Morris and Tara Smydra, Dean and Associate Dean of Agriculture, Math presented the program review for the Agriculture programs with support for the programs being provided by the respective instructor. Dr. Michele Gill reported that collectively, the Agriculture programs at Northeast Community College exceed the threshold established by the Nebraska Coordinating Commission for Postsecondary Education (CCPE) for Student Credit Hour (SCH) of 275 hours and a minimum of ten (10) degrees awarded in a five year time period. Individually, the Precision Agriculture program falls slightly below the CCPE threshold for number of degrees awarded in a five-year period. This program has only been in existence for four years and had good enrollment so there are no concerns with meeting the threshold in the future.

There are fewer acres to raise food to feed the nation so farmers must be more efficient with the acres that are available. Ag faculty continually collaborate to constantly improve the students' education and provide them with a broad base of knowledge. A large number of agriculture students come from family farms or ranch operations and are seeking to return to their operation upon graduation. A significant number of students go to work for employers in the industry while continuing to contribute to their family operations.

Mission

Northeast Community College is dedicated to the success of students and the region it serves.

Faculty members expressed their appreciation to the Board of Governors for approving the construction of the new Ag facilities and keeping our students safe. Instructors are able to teach the theory in the classroom and then take students to the field for the hands-on experience. These experiences have proven to be invaluable.

Support of and the need for the Agriculture programs was confirmed during discussion. A consensus was reached by the members of the Student Success Committee to recommend to the Board of Governors to approve the continuation of the Agriculture programs at Northeast Community College for submission to the Nebraska CCPE.

4. Amanda Nipp, Vice President, Student Services, reported that summer enrollment is up 44% or 437 more student compared to summer 2020. Compared to summer 2019 summer enrollment is up 288 students.

Fall enrollments also reflect an increase of 68% compared to 2020 and 24% compared to 2019.

5. Scott Gray advised that the construction report is a written report that is available in the Facilities Committee within BoardPaq. Due to time limitations, the Facilities Committee will not be convened.

Comment was shared that many students cannot afford to attend a four-year or private institution. Students who attend Northeast Community College are not second-class citizens and they deserve the student union opportunities provided in Union 73.

6. With no further business to discuss, the meeting was adjourned at 11:58 a.m.

- 1. Nicole Sedlacek, Chairperson of the External Relations Committee, convened the meeting at 12:16 p.m. in Room 1108B of the College Welcome Center.

- 3. Greg Adams has announced his retirement effective December 31, 2021. During a meeting last week in Lincoln, the timeline for filling the executive director position was discussed and includes having the new person begin on November 1st, allowing two months of time for the individual to work with Greg Adams prior to his departure. - 5. The Nebraska Legislature has adjourned but Dr. Tracy Kruse will continue to monitor interim studies that are held throughout the summer.

A contract was awarded to complete Hwy. 275 between West Point and Scribner. Construction should begin sometime this summer.

- 6. Discussion was held regarding America's College Promise Act, the current proposal for free community college. The Nebraska Community College Association (NCCA) and the Association of Community Colleges Trustees (ACCT) will continue to have discussions on the variances of how the funds would be received from the federal government, funneled to the states, and distributed to the colleges. The Northeast Community College Area Board of Governors will have future conversations to understand what the free community college proposal means for us.
- 7. Amanda Nipp provided an analysis of Northeast's Debt Forgiveness Program, outlining the eligibility requirements. She reported that a total of 473 students, with a median debt of \$459 owed, are eligible for this one-time opportunity.
