Board of Governors Northeast Community College Area Minutes of Meeting Thursday, December 9, 2021

1. BOARD EDUCATION AND INFORMATION

A tour was taken of the new Veterinary Technology facility.

2. VICE PRESIDENT REPORTS

2.1. <u>Administrative Services Report:</u>

2.1.1. Facilities Update/Progress

A walk through of the new Veterinary Technology facility occurred earlier today. A team of people went through the facility last Friday to develop a plan for moving in and occupying the building so that everything is ready to begin spring semester classes. A date has not yet been established for the demolition of the old Vet Tech facility.

The new facility will provide opportunities for program area growth to occur through continuing education. This would be a new population of students for Northeast that would not require additional instructors.

Maclay Building is slated for reconstruction. To begin to empty the building, the President's Office, Technology Services, and Marketing will be permanently relocated to the Lifelong Learning Center. The layout for the offices in the Lifelong Learning Center will be finalized by the end of 2021. Decisions for programming in the Maclay Building continue to be discussed. Goal is to begin reconstruction/remodel of the Maclay Building in January 2023.

2.1.2 Monthly Financial Report and Paid Bills

Monthly Financial Statement and paid bills were reviewed; with focus being given to paid bills in excess of \$5,000, many of which are tied to vendors related to the new Vet Tech facility.

2.1.3 Room and Board Rates

Data from Chartwells has been received and reviewed and equates to an increase of 2.51%, or \$112 per semester, in average housing and meal plan rates. The average room and board rates for 2022-2023 will be \$4,570.00.

2.2 <u>Development/External Affairs Report</u>

2.2.1 Legislative Update

Drs. Leah Barrett and Tracy Kruse met recently with Senator Joni Albrecht and they continue to reach out to meet with other area senators. These meetings provide opportunities to share Northeast's priorities with them. Another main area of discussion was related to community college's request for receiving American Rescue Plan Act (ARPA) funds.

2.2.2 President's Update

Governor Ricketts has requested additional information to support the requests from community colleges. We are optimistic that the governor's budget will be released to the legislature prior to the holidays. The next legislative session convenes on January 5, 2022. This will be the second year of the biennium budget.

Northeast continues to work closely with the Nebraska Chamber of Commerce related to the Good Jobs Challenge tied to a manufacturing grant. Along with 18 other partners, Northeast is involved in another request for the Good Jobs Challenge that is focused on the transportation and construction industries. The Nebraska Chamber has confirmed that they will be supportive of our separate Good Jobs Challenge request. Board members are encouraged to advocate for these various initiatives.

Early enrollment data reveals that several of Northeast's programs are at full capacity with students on the wait list. If received, part of the ARPA funds would be used for facility needs and investing in our technical fields.

Northeast is excited to have signed an agreement to provide an annual allocation to the North Fork Area Transit so that our students can access those services for free.

Recently, a group of community members from Norfolk traveled to Lincoln recently to tour Innovation Campus, Johnny Carson Center for Emerging Arts, and the Engler Center. The intent is to build energy and enthusiasm for construction of a Maker's Space in Norfolk.

4.1 <u>Committee Structure – Roles, Responsibilities, and Membership</u>

4.1.1 Governance Committee

Committee will continue as is to review and recommend changes to policies on a monthly basis.

4.1.2 Ownership Linkage Committee

Committee will identify opportunities to meet with school leaders, county officials, and other owners throughout the year. This committee and the administration may influence ideas for the education of the board.

4.1.3 Search Committee

4.1.3.1 <u>Discuss role and responsibilities</u>

Role will be to fill vacancies of the board. This committee will only meet on an as-needed basis.

4.1.3.2 Process for election of board positions

Board officers will be identified in December and begin serving their term in January. Board members have the opportunity to indicate their interest in serving as an officer for 2022. The vice chairperson will move up to chairperson and the secretary will move up to vice chairperson the following year. Other board members would have the opportunity to serve as secretary and rotate up through the officer positions. Should it become a challenge to fill the officer position, it would default to the previous method of filling positions by length of service on the board. The recording secretary maintains this list. The incoming Chairperson will determine membership of the three committees.

4.1.3.3 Review process for filling vacant board position

The vacant positions will be advertised in the Norfolk Daily News as well as the local newspapers in the counties of the respective districts. Advertising will begin in January with applications being received in the President's Office through January 28, 2022. Members of the Search Committee will review applications and interviews will be conducted the week of January 31st with the appointments taking place during the January 17, 2022 meeting 4.1.3.3.1 Identify Search Committee members

The 2022 Chairperson will identify the Search Committee members.

4.2 NCCA Board of Directors

Steve Anderson and Nicole Sedlacek have expressed interest and will continue to serve as Northeast Community College's representatives on the NCCA Board of Directors, with the remainder of the Board serving as alternates.

4.3 Other (Ad Hoc) Committees

Ad Hoc Committees will be created on an as-needed basis.
