A Public Hearing was held on the possible acquisition of real estate: A tract of land located in the southeast quarter of section 14, township 24 north, range 1 west of the 6th P.M., Madison County, Nebraska, beginning at a point 490.0 feet west and 33 feet north of the southeast corner of said section 14; thence north 180 feet; thence west 100 feet; thence south 180 feet; thence east 100 feet to the place of beginning; excepting however a tract of land conveyed to the State of Nebraska located in the southeast quarter of said section 14 described as follows: referring to the southeast corner of said quarter section; thence northerly a distance of 33.01 feet along the east line of said quarter section; thence westerly deflecting 091 degrees 11 minutes 21 seconds left a distance of 490.31 feet to the southeast corner of the property owned by grantor(s) to the point of beginning; thence westerly deflecting 000 degrees 00 minutes 00 seconds a distance of 100.00 feet to the southwest corner of the property owned by the grantor(s); thence northerly deflecting 090 degrees 07 minutes 30 seconds right a distance of 2.00 feet along the west line of the property owned by the grantor(s); thence easterly deflecting 089 degrees 52 minutes 30 seconds right a distance of 100.00 feet to a point on the east line of the property owned by the grantor(s); thence southerly deflecting 090 degrees 07 minutes 30 seconds right a distance of 2.00 feet along said line to the point of beginning.
