6. BOARD EDUCATION AND INFORMATION

- 6.1 Administrative Services Report
 - 6.1.1 Monthly Financial Report and Paid Bills

Review was given to the financial report for the period ending May 31, 2023, along with some of the larger fund changes related to receipt of property taxes and ARPA funds. Items of significance within the May paid bills report included payments to Huff Construction for modifications being done to the Lifelong Learning Center, Mid-West 3D Solutions Inc. for the purchase of a MechLab Training System used in training students in the manufacturing program, and Kustom Kitchens related to the purchase of the building downtown and the relocation assistance allowed by law.

6.2 Development/External Relations Report

6.2.1 NCCA Report

The 2023 legislative session is over and will be remembered for all of the filibusters. State employees overtime was doubled compared to a year ago and the state patrol had 14% in additional costs due to covering protests.

The NCCA Executive Board Meeting will be conducted on July 17th and the third quarter NCCA Board Meeting and strategic planning session is scheduled to be held on August 7th.

- 6.2.2 Legislative update
 - The community college budget is within the Appropriations Budget. Community colleges originally requested a 3.5% increase plus 1% for dual enrollment and received a 1.97% increase.
 - Three additional appropriations that support community colleges include:
 - LB610-CTE funding provides for a \$5MM annual increase.
 - $\circ~$ LB586-Training clinical nurse faculty \$10MM in one-time monies.
 - LB385-Teacher retention and recruitment one-time monies for dual enrollment training incentive.
 - Community College Future Fund provides:
 - Annual increase of 3.5%.
 - Retention of the 2-cent capital levy authority.
 - Ability to return to the property tax if state fund obligations are not met.
- 6.2.3 President's update
 - The Farm Bill now provides funding for training of technicians at community colleges.
 - ACCT Connect is the new primary communication tool that provides an avenue for trustees to engage and communicate. It will also keep trustees updated with activities occurring at and information from community colleges across the nation. Board members are encouraged to sign up to receive updates.
 - Four bids were received for the Maclay Building project with Hausmann Construction being awarded the bid. Scott Gray is working with Hausmann to finalize the schedule so that construction can begin.
 - Norfolk Area Childcare Co-op, led by Daycos, is a non-profit group that would create a childcare facility to serve the greater Norfolk region. Eight area CEOs are involved in the discussions.
- 6.2.4 Naming of the LLC community room

A written nomination for officially naming the community room in the Lifelong Learning Center was presented for consideration by the Board of Governors. The nominee has given generously of his time, knowledge, talent, and financial resources for many decades. Dr. Kruse requested that the information remain confidential until the nominee has been contacted. The written nomination is available within today's Teams site. A naming event will occur in conjunction with the August 10th Board of Governors meeting.

6.2.5 HLC update: Criterion 5, Institutional Effectiveness, Resources, and Planning. The institution's resources, structures, and processes are sufficient to fulfill its mission, improve the quality of its educational offerings, and respond to future challenges and opportunities.

6.3 Educational Services Report

6.3.1 The Educational Services Team is recommending the removal of the Food Service/Dietary Management program from its course offerings at Northeast. The program continues to have the same enrollment concerns noted by the Board of Governors during the 2016 review and prospects for future enrollment are bleak.

The Food Service/Dietary Management program is listed in the 2023-2024 catalog. Northeast will serve students enrolled for the fall 2023 start and also need to serve the students currently enrolled as part of the accreditation teach out requirements. The courses will be taught online with adjunct faculty.

The Food Service/Dietary Management program will go through the process outlined by policy to sunset the program and it will not be included in the 2024-2025 catalog.

Northeast will continue to work with the advisory board during the 2023-2024 academic year to determine the best way to serve our communities, including the exploration of moving the program to a workforce training model.

8.1 Governance Committee

- The Governance Committee conducted a Content Review (CR) of the following:
- EL-01, <u>Treatment of Students</u>. The policy was reviewed and there are no recommendations for revision.
- EL-02, <u>Access to Education</u>. No recommendations for revisions. Due to the passage of LB243, Item #1 will be taken to the Board for discussion regarding the property tax levy. The Governance Committee believes that the policy should be reviewed again next year after there is an opportunity to see what impact LB243 has on tuition.

The first and second reading of policies, as recommended by the Governance Committee, was inadvertently omitted from the June agenda and will be included for consideration on the July 13, 2023 agenda.
