



## Unusual Enrollment History (UEH) Certification 2024-2025

Your 2024-2025 Free Application for Federal Student Aid (FAFSA) was flagged for Unusual Enrollment History because you received Federal Grants and/or Loans at multiple educational institutions during the review period of 2020-21, 2021-22, 2022-23, and 2023-2024. ### How to resolve:

Select students with the National Student Loan Data System of Students (NSLDS) UEH Flag of 2 and all students with the NSLDS UEH Flag of 3 listed on their Student Aid Report (SAR) will be required to provide Northeast Community College a copy of their official academic transcripts from all colleges and universities previously attended. If Pell Grant and/or Loans were received and credit hours (passing grades: A - D) were not earned at each institution attended during these award years, the student may be determined ineligible for further federal financial aid. The Financial Aid Office has the authority to require an official academic transcript from any/all colleges attended.

- Request official academic transcript from all previously attended institutions and have them sent to the Northeast Community College Registrar’s Office.
