

#### John Schmitt

He has also served as a board member and treasurer of Blind Corps, Incorporated.

Schmitt followed in the footsteps of his father, Clarence Schmitt, who served as a long time member of Northeast Community College Board of Governors.

Schmitt said, "Northeast gave me the opportunity to acquire skills that have allowed me to find meaningful employment. I have gained some lifelong friendships with both staff and students of the College. ## Distinguished Service



#### Dr. Don Oelsligle

Dr. Don Oelsligle served on the Northeast Board of Governors, representing District I of Antelope, Garfield, Pierce and Wheeler counties in their entirety and portions of Boone, Cedar and Madison counties, from 2000-2017. He chaired a number of board committees and served as board chairperson in 2007. He was board vice-chairperson in 2006 and 2012.

Oelsligle also participated in the American Association of Community College Trustees and American Association of Community Colleges meetings in Washington, D.C., on behalf of Northeast. He also served as one of two representatives from Northeast on the Nebraska Community College Association (NCCA) Board of Directors, including a one-year term as board president in 2011. He earned the NCCA Governor's Award in 2012.

His vast experience as a researcher, educator, Peace Corps volunteer, manager, agribusinessman, and farmer prepared him to function as an outstanding contributor to the board. Oelsligle's dedication and passion for students over the years is commendable and deeply valued.

An area of importance to Oelsligle has been Northeast's continued expansion in global educational opportunities, which include the development of student exchange programs, an increase in the College's international student population, articulation agreements with institutions in other countries and the Center for Global Engagement.

#### **Shirley Petsche**

Shirley Petsche has served on the Northeast Community College Board of Governors, representing District I of Antelope, Garfield, Pierce, Wayne and Wheeler counties in their entirety and portions of Boone, Cedar, and Madison counties, since she was appointed in 2010. She was elected to the position in 2012 and re-elected in 2016. Petsche stepped down from her position in August 2018.

#### Turning 70 1/2? Have an IRA? What are RMDs?



We spoke with Tracey Buettner, an attorney at Stratton, DeLay, Doele, Carlson, Buettner & Stover, P.C., L.L.O. about retirement planning around Individual Retirement Accounts (IRA). At age 70 ½, the Internal Revenue Service (IRS) requires that people who hold individual retirement accounts begin taking required minimum distributions (RMDs) from their retirement accounts. A required minimum distribution is simply a mandatory withdrawal that you must make annually from your retirement accounts, upon reaching the age of 70½. Your RMD is based on your account balance from Dec. 31 of the previous year, and is taxable income that may add to your annual tax burden. What's more, failure to withdraw the RMD on time could result in a 50 percent penalty.

"It is essential for estate planning purposes to have an idea of what your RMD might be. There are several investment businesses that provide online calculators, but the IRS website is a good place to start," said Buettner. "The IRS has actuarial tables that provide life-expectancy information used to calculate RMD based on your account balance."

Your RMD is your money, you can spend it or reinvest it. But once you take possession of your funds, it becomes taxable income that may have tax repercussions. Buettner suggests, "Another option to discuss with your estate planning advisors is to donate the RMD directly to charity. It is a way to keep your income lower for tax purposes." This is called an IRA charitable rollover.

"Your estate planning advisors will ensure the donation is given correctly to take advantage of the income tax benefits. It's important the donation goes directly from the asset to the 501(c)(3) charity. There is also a \$100,000 per year limit," she added. Withdrawing an RMD doesn't have to be a source of stress, and can be a great opportunity to support Northeast Community College or a charity of your choice. If you are interested in establishing Northeast Community College as a recipient of all or part of your RMD, please contact your professional advisor.

#### Planned Giving and You

Many of our family and friends who support Northeast Community College Foundation say they love supporting our work and wish they could do more. One way to do more is to include Northeast in your estate plan. Some believe you need to be "super wealthy" to leave a charity in your estate plans, but that is far from the truth. As little as 1% of your estate would make a difference at Northeast. It is possible to provide for your family and invest in your favorite charity at the same time.

Planned gifts include bequests in wills or living trusts (or a bequest in a will or a living trust); life income plans such as gift annuities, charitable trusts and pooled income funds; and beneficiary designation of retirement plans, brokerage accounts and life insurance policies.

At Northeast, all unrestricted charitable gifts are used strategically to support the education of our students.

To make a one-time gift, or an estate gift to the Northeast Community College Foundation, the appropriate beneficiary designation is "Northeast Community College Foundation, a Nebraska nonprofit corporation." Northeast Community College Foundation is registered with the IRS Department of the Treasury (EIN: 51-0145185) and is exempt from federal income tax under the provisions of Section 501(c)(3) of the Internal Revenue Code of 1954.
