### Preston Love, Jr.

Preston Love, Jr. graduated from Norfolk Junior College, a predecessor institution of Northeast Community College, in 1963 with an Associate of Arts degree. He later went on to earn a Bachelor of Science in Economics from the University of Nebraska-Lincoln and a master's in Professional Studies from Bellevue University.

Love played football at the University of Nebraska and was drafted by the NFL's Detroit Lions. He was inducted into the Nebraska Black Sports Hall of Fame in 2016.

As a businessman, Love served in the corporate world with IBM for 15 years. He went from business to politics, helping Jesse Jackson run for the Democratic nomination for President in 1984. From politics, Love founded Black Votes Matter Institute of Community Engagement and, most recently, the Institute for Urban Development. In 2020, he was asked to be the Nebraska Democratic Party's endorsed candidate for U.S. Senate.

Love's career accomplishments are many. He is an adjunct professor at the University of Nebraska-Omaha. He is also a playwright, author, an award-winning newspaper columnist, a national lecturer, and a contributor to the Fine Lines Journal. In addition, Love serves as first vice president of the National Association for the Advancement of Colored People (NAACP) in Omaha and is a board member of Kids Can Center.

### Stanley (Stan) Timm

Stanley Timm graduated from Norfolk Junior College in May 1968, with an Associate of Arts degree. Immediately after graduation, he worked at a manufacturing plant in Neligh and then moved to Omaha to further his education where he earned a Bachelor of Science degree in Business with an Accounting major from Creighton University in 1972.

Timm then began a 50+-year career in the City of Omaha Finance Department including serving as executive director of the Omaha Housing Authority and as the city's chief financial officer under two mayoral administrations. He worked, in part, with a total of 12 administrations during his career. In those roles he instituted best practices and led teams in municipal bond financing on major projects such as the CHI Health Center Arena and Convention Center.

Timm has also contributed his time and talents to several organizations such as the North Omaha Development Project, Douglas County Re-entry Task Force, South Omaha Violence Intervention and Prevention Partnership, Building Bright Futures Truancy Prevention Program, YMCA Strong Kids Campaign, and the Muscular Dystrophy Association. He has also been a fundraiser for United Way of the Midlands and has volunteered as a youth basketball and soccer coach.

### James A. McKenzie

James A. McKenzie earned an Associate of Applied Technology degree in data processing from Northeast Technical Community College in 1980. Following graduation, he took a position with the Norfolk Livestock Market as controller and information technology manager. It was there he met his lifelong mentor, Randy Emrich, whose family owned the market.

Emrich provided the business knowledge and capital to help McKenzie begin the company, Business Management Software (BMS), at age 24. BMS became an IBM business partner and sold midrange computer systems and developed software for businesses located across the central United States. McKenzie eventually sold BMS to focus on family and then took the position of information systems manager for the City of Norfolk, where he has served for the past 25 years.

The City of Norfolk's technology infrastructure would not be where it is today without McKenzie's expertise. The projects he has worked on range from evolving the city's computer and phone systems to designing and overseeing the development of Norfolk's fiber optic network to major projects in several new facilities including the renovated and expanded public library, second fire station and Aquaventure waterpark.

# Planned Giving

### End of Year Means Changes to SS, Retirement Accounts, Taxes

The beginning of the new year will mean changes in both federal and state policy concerning Social Security, retirement accounts and taxes.

For those enjoying their retirement and already drawing Social Security, two key changes are coming. Retirees will receive larger checks, and those Social Security recipients still working can earn more without losing benefits.

More than 64-million Americans will see a 5.9% increase in their gross Social Security amount. The nearly 6% increase means the average Social Security benefit for a retired worker will rise by \$92 a month, to \$1,657, and the average benefit for a retired couple will grow \$154 a month to \$2,753. Some other retirement plans apply the same COLA to their benefits, meaning some seniors could receive similar increases from those income sources.

Recipients are cautioned, however, that they will not see all of that reflected on their monthly checks. Medicare's Part B monthly premium for 2022 will increase by \$21.60. Standard monthly premiums for Part

B will cost \$170.10 in 2022, up from \$148.50 in 2021. Premiums for about 7% of Medicare enrollees with annual incomes greater than \$91,000 will be higher than the standard because these monthly payments are based on income.

The earnings limit for those less than full retirement age who are drawing Social Security will increase in 2022. Recipients under full retirement age will be docked \$1 in benefits for every \$2 in monthly earnings above \$1,630 after January 1, an increase from the current limit of \$1,580.

Some younger workers will be paying more Social Security taxes in 2022. According to Forbes.com, the maximum amount of earnings subject to Social Security tax will rise 2.9% to \$147,000, from \$142,800 in 2021. That means a bigger tax bill for about 12-million high-earning workers.

For those contributing to, or withdrawing from, qualified retirement accounts, the IRS has made several updates in the ceilings and thresholds. For instance, the limitation on deferrals for most retirement plans increases to \$20,500 for 2022. The annual compensation limit also increases from \$290,000 to \$305,000. For Nebraska residents, state taxes on Social Security earnings will be phased out over a 10-year period. The first year's phase out is 5%, then 20% the second year, and an additional 10% each year after that with the goal of total elimination of the tax by 2030.

The plan will be reviewed after five years, however, to make sure the state has the revenue to support the total phase out. Another change in Nebraska tax law exempts military retirement income from state taxes beginning in 2022.

It is always a good idea to check with your financial advisor at the end of the year to see how changes in federal and state policy will affect your individual financial situation.
