To prepare this monitoring report, Board members were surveyed to provide evidence of compliance. 9 of the 11 members of the board completed the survey and the results suggest compliance with the policy. The results are provided as evidence to support the interpretation.

## The President shall not permit the board to be uninformed or unsupported in its work.

<u>INTERPRETATION</u> – The President provides updates to the board as part of the monthly meeting. These include progress on strategic priorities, governmental relations – both state and federal, college culture, student engagement, enrollment, and external relations. The President also provides updates, as appropriate, between meetings to ensure board members are well-informed as it relates to their roles and responsibilities and impending decisions.

Information is also provided by cabinet members in the board meeting as *Board Information & Education* that provides additional context. Statewide, regional and national information is also often provided to learn about industry trends, benchmarks, and best practice.

<u>INTERPRETATION</u> - As part of the monthly board information, a summary of expenses and account status of the Board account is provided. As it pertains to risk assessment, the president and counsel provide regular interpretation of the open meetings law to ensure compliance. The Northeast Community College Board of Governors has been in compliance with these laws. Moreover, updates to the county-wide joint public hearing occurred during the 2022 legislative session. The President and General Counsel has provided information that ensures that the Northeast Community College Board of Governors has limited the risk of non-compliance with new statutes.

The reports provided evidence of compliance. There have been cases where there is need for improvement or an area of weakness. The report provides an opportunity to provide context and a plan of action to improve.

<u>INTERPRETATION</u> – The president approaches communication with the board with a spirit of "no surprises" and the perspective that too much information is better than too little. There have been multiple situations where it has been appropriate to inform the board of college activities in between board meeting, whether it be related to proposed changes or developments to the community college funding formula; celebrations, awards or recognitions; or announcements like the release of certified land valuations. During the 2023 legislative session, the president distributed almost weekly updates to the board and shared communications from the Nebraska Community College Executive Director. The public information officer distributes press releases to board members on a weekly basis; and board members receive the weekly college newsletter. The president's update at the monthly board meetings often includes more detailed information that may provide additional context of be of interest to the media.

<u>INTERPRETATION</u> – The President meets on a regular basis with the Board Chair and would utilize this time to discuss if a situation arose where the President felt that the Board was not in compliance with its own policies. The VPAS/Legal Counsel meets monthly with the Governance Committee for policy review and recommendations for improvement, preparation for the next meeting, and to discuss board performance. The President meets every other month with the Ownership Linkage Committee to review activities and plan for future opportunities for ownership linkage. These three regular activities allow for trust building and open communication around board

compliance with its polices and Board behavior that may be detrimental to the working relationship between the Board and the President.

### **EVIDENCE**

A situation occurred this year where some board members voiced concern about compliance with Board policies as it related to election of officers. Time was taken to revisit and revise the policy and review the board actions. Additionally, the board retreat provided a great opportunity to discuss process improvements as they relate to the monitoring reports and the board self-evaluation. The forms provided by the *Governance Coach* were reviewed and updated and more clearly integrated into the monthly board meetings.

<u>INTERPRETATION</u> – On a monthly basis the President & Cabinet members present financial information, enrollment data, and updates on strategic priorities that support board decision making, articulate compliance with Executive Limitations, and keep the Board informed of

activities of the College. Every attempt is made to ensure the content is clear, concise, and easily understood and the reason that the information is provided (ie, monitoring, decision making, or general information).

### **EVIDENCE**

The Board has spent an extensive and appropriate amount of time talking about the changes and impacts of the Community College Future Fund. The way in which this occurred required significant engagement by the Board members in advocacy and relationship building. The community college funding formula continues to be complex and requires Board attention that includes monitoring the president's performance, decision preparation, planning, and alignment with the Ends. The President and Legal Counsel made every attempt to communicate and interpret the evolving situation from the initial discussions with the Governor in January 2023 to the final votes in April.

<u>INTERPRETATION</u> – The Executive Assistant to the President serves as the Board Recording Secretary (GP-06). She consults regularly with the VPFA/Legal Counsel on topics such as the Nebraska Open Meetings Law and records retention. There has not been a situation in the past year where there has been a question that the Board is not meeting all legal requirements. The Executive Assistant also works closely with the Secretary of State's Office and County Clerks on voting and redistricting. These responsibilities are articulated in Board Policy and in the job description.

<u>INTERPRETATION</u> – On a monthly basis, the President, Board Secretary, and VPAS/Legal Counsel review the legal obligations of the board and those requirements outlined in Board Policies to ensure they are included in the *Items for Decision* (ie, Required Approvals) section of the agenda. The draft agenda is also reviewed by the Board Chair before it is finalized. For the most part, the schedule for monitoring reports has been adhered to; the Board Chair was consulted prior to any deviation.

## **EVIDENCE**

The Truth in Taxation Law (ie, the postcard and accompanying joint public hearing) does not align with our traditional board processes for setting our levy. Although we fumbled a bit with timing in 2022 and 2023, the law has been followed and all submittals were and will be filed prior to the deadlines.
